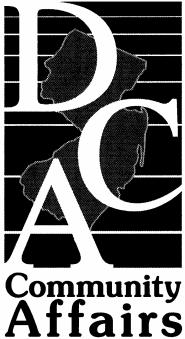

WHEREAS, the Annual Budget for the Montville Township Fire District No. <u>3 for the fiscal</u> year beginning January 1, 2013 and ending December 31, 2013 has been presented before the Board of Commissioners of the Fire District No.<u>3</u> at its open public meeting of <u>November 21, 2012</u>; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.) *Include the following as appropriate: [includes a proposed public referendum in the amount of* \$______ *in excess of the allowable amount to be raised by taxation] [includes a proposed public referendum in the amount of* \$______ *as an appropriation from restricted fund balance to be used as a budget revenue]*; and,

WHEREAS, the Annual Budget as introduced reflects Total Revenues of $\frac{624,700}{540,000}$, which includes amount to be raised by taxation of $\frac{540,000}{540,000}$, and Total Appropriations of $\frac{624,700}{524,700}$; and

WHEREAS, the amount to be raised by taxation to support the district budget, shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. <u>3</u> has taken into account the assessed valuation of taxable property in the Fire District No.3_,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Montville Township Fire District No. <u>3</u>, at an open public meeting held on <u>Nov. 21, 2012</u> that the Annual Budget, including appended Supplemental Schedules, of the <u>Montville Township</u> Fire District No. <u>3</u> for the fiscal year beginning January 1, 2013 and ending December 31, 2013 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District No.<u>3</u>'s outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the <u>Montville Township</u> Fire District No 3will consider the Annual Budget for adoption on <u>December 19, 2012</u>.

There are no increases or decreases. The 2013 Budget is the same as 2012 Amount to be raised by taxation

The Fire District has a Capital Savings for new truck purchase, and capital savings for Emergency Equipment. This provides the Fire District with the available funds for future purchases. We are not exceeding the levy cap.

The Fire District Debt Service is 2103 - \$63,131, 2014 - \$63.135 and 2015 - \$36,795. The current capital line item will be utilized to purchase new fire apparatus in approx.. 5 years to replace a 1983 Hahn pumper. The capital equipment line is to use for emergency equipment replacement.

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.)[include as appropriate: includes a proposed public referendum in the amount of \$______ in excess of the allowable amount to be raised by taxation] [includes a proposed public referendum in the amount of \$______ as an appropriation from restricted fund balance to be used as a budget revenue]]; and,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the <u>Montville</u> <u>Township</u> Fire District No. <u>3</u>, at an open public meeting held on <u>December 19, 2012</u> that the Annual Budget of the <u>Montville Township</u> Fire District No. <u>3</u> for the fiscal year beginning January 1, 2013 and ending December 31, 2013 is hereby adopted and, [subject to the proposed referendum being approved by 50 percent of the voters] shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$,<u>\$624,700</u> which includes amount to be raised by taxation of \$<u>540,000</u> and Total Appropriations of \$<u>624,700</u>; and,

BE IT FURTHER RESOLVED, that the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and,

BE IT FURTHER RESOLVED, that an annual election shall be held on the third Saturday of February to determine the amount of money to be raised by taxation for the ensuing year. The results of which shall be subsequently certified to the Division and the Municipal Assessor.
