Regular Meeting January 19, 2011

The Board of Fire Commissioners, Fire District No. 3, held a regular meeting on Wednesday, January 19, 2011, 47 Bloomfield Avenue, Pine Brook, New Jersey 07058 at 7:00 PM.

Present: Anthony Speciale, Ronald Cain Jr., Edward Rosenbergen, Timothy Wright and Donald Hainzl

Also Present: Fire Official Robert Schmitt and Fire Chief Herbert Eggers Jr.

Chairman Speciale called the meeting to order at 7:00 PM.

Chairman Speciale led the flag salute.

R. Cain Jr. said the ceiling fans have been replaced in the bays at Station No. 1 and Station No. 2.

Insurance is up to date; the Board will begin requesting quotes in March. The current policy is in effect until May 14, 2011.

Chairman Speciale said that he will contact Fire & Safety to look at the truck as there is some concern with rust on the Pierce. The clutch on 378 will be looked at this week.

R. Cain Jr. said that the roof project has been completed, the Board is waiting to receive the Maintenance Bond and Manufacturer Warranty before the bill will be paid.

Chairman Speciale said that nothing has been done with the County Dispatch at this time.

Chairman Speciale asked Chief Eggers the progress on the new fire apparatus. Chief Eggers said that they should have everything ready to present to the Board at February's meeting.

Discussion concerning reimbursement to Life Members attending Wildwood Convention will be discussed at next month's meeting. R. Cain Jr. will talk to Lincoln Park and Towaco and see what they do.

Chairman Speciale discussed pay increases for the employees. R. Cain Jr. recused himself from this portion of the meeting. Chairman Speciale opened it up for the Board's discussion. Following discussion E. Rosenbergen made a motion for a 2% raise to all employees seconded by T. Wright. Roll Call: T. Wright.-Yes, D. Hainzl-Yes, E. Rosenbergen-Yes and A. Speciale-Yes. Chairman Speciale asked for a motion to open meeting to public to discuss. Motion by T. Wright to open meeting seconded by E. Rosenbergen. Discussion brought up was possibly increasing Fire Prevention fees to generate additional income for the Bureau. Motion by D. Hainzl to close public portion seconded by E. Rosenbergen.

H. Eggers mentioned that the Smoke Detector Inspection fee is \$35 which is too low in comparison to other towns. H. Eggers said that at some point the Board might have to subsidize the Fire Prevention Bureau. Fire Official Schmitt suggested that the fees be discussed now so they can be increased in 2012. D. Hainzl suggested Fire Official Schmitt begin the process of setting up meetings with the three Districts to get this started. R. Cain Jr. asked how come vacant buildings do not pay a registration fee. The

Board will have the attorney give an interpretation of the existing ordinance and see if the Bureau should be collecting a registration fee from building owners.

Motion by T. Wright to go into closed session seconded by E. Rosenbergen.
