Resolution 2012-001

A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF FIRE DISTRICT NO. 3, IN THE TOWNSHIP OF MONTVILLE, COUNTY OF MORRIS, AUTHORIZING THE SALE OF A 1972 HAHN 1500 GALLON PER MINUTE PUMPER/55 FT. TELE-SQUIRT

WHEREAS, the Board of Fire Commissioners of Fire District No. 3, in the Township of Montville, County of Morris (the "Fire District"), is the owner and is in possession of a 1972 Hahn 1500 Gallon Per Minute Pumper/55 ft. Tele-Squirt (hereinafter "Fire Truck"); and

WHEREAS, the Fire District has determined that the Fire Truck is no longer needed for public purposes; and

WHEREAS, the Fire District wishes to sell the Fire Truck to the highest bidder through sealed bids pursuant to the provisions of N.J.S.A. 40A:11-36.

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of Fire District No. 3 in the Township of Montville, County of Morris, and State of New Jersey as follows:

- 1. The Fire District's 1972 Hahn 1500 Gallon Per Minute Pumper/55 ft. Tele-Squirt is hereby declared to be surplus and no longer needed for public purposes.
- 2. The Fire District Clerk is hereby authorized and directed to advertise the Fire Truck for public sale, which sale shall be held at Fire Station No. 2 located at 77 Konner Avenue, Pine Brook, New Jersey, 07058 on <u>March 15</u>, 2012, at 11:00 a.m.
- 3. The public may inspect the Fire Truck on <u>March 15</u>, 2012, between the hours of <u>10:00 AM</u> and <u>11:00 AM</u> at Fire Station No. 2 located at 77 Konner Avenue, Pine Brook, New Jersey, 07058 or by calling 973-227-8071.
- 4. The Fire Truck shall be sold in an "as is" condition with no representation as to the condition or use of the vehicle and no warranty, either express or implied, is made by the Fire District in connection with the sale of said vehicle.
- 5. The sale shall be conducted through sealed bids and the Fire District reserves the right to accept or reject any bid or to waive any informality therein in the sole discretion of the Fire District.

- 7. The sale of the Fire Truck shall be final and no refunds shall be made. The Fire Truck must be removed from the Fire District's premises within fourteen (14) days of the date of the sale, or the successful bidder's deposit shall be forfeited to the Fire District and the Fire Truck shall be sold to the next highest bidder.
 - 8. This Resolution shall take effect immediately.
