Chairman Speciale called the meeting to order at 7:00 PM.

Chairman Speciale led the flag salute.

#### Building & Grounds:

Two proposals were received late today, E. Rosenbergen and R. Cain Jr. will review them and make sure all the required documents are in order and review the pricing. R. Cain Jr. suggested since the lawn maintenance should have been awarded at this meeting, would the Board want to do a poll after the review is complete. Board agreed a poll should be done.

R. Cain Jr. said that Insurance is due for renewal May 14, 2011. The Board is receiving quotes for insurance.

T. Wright said we should be receiving the first tax check from Montville Township in April.

A. Speciale said that Big John will be picking up 377 either Thursday March 17th or Friday 18th of this week. He will be checking to see why there is a pressure problem with the truck. R. Cain Jr. said that 378 heater had a leak; it was bypassed so the truck is running. Board said they will not repair as the truck is being replaced with new Pumper/rescue truck. R. Cain Jr. discussed having Fire & Safety do all the repairs to the trucks when they are here for the annual service. If they need authorization then we will give it when the Board schedules the regular maintenance. R. Cain Jr. said a lot of the issues could be eliminated if the engineers did the weekly checks on the trucks. A. Speciale will contact Fire & Safety and have them do the repairs when they are servicing them.

R. Cain mentioned the generator is not working at this time. Davis Carburetor has been here, the circuit board is no good. They are going to get a price to repair or rebuild.

Rosenbergen and Chief Eggers said that PEOSHA will comes in and assist you in getting everything up to PEOSHA standards. One of the things departments are being cited for is pump certification. This is something that can be discussed at the Joint Commissioners meeting.

Chief Eggers asked what were some of the issues with the Specifications that need to be addressed, R. Cain Jr. said that it does not ask for any Mask bags, Chief said that they want them; also there are no trips schedule in the specifications. Chief Eggers said they cannot be put in Specifications. Chief and Officers will sit down with R. Cain Jr. and another commissioner to go over the specifications to make sure everything is correct prior to bid publication.

R. Cain Jr. thanked A. Speciale for serving as Chairman of the Board for many years.
