Regular Meeting July 20, 2016

The Board of Fire Commissioners, Fire District No. 3, held a regular meeting on Wednesday, July 20, 2016, 47 Bloomfield Avenue, Pine Brook, New Jersey 07058 at 7:00 PM.

Present: Anthony Speciale, Ronald R. Cain Jr., and Donald Hainzl.

Absent: Timothy Wright and Edward Rosenbergen Sr.

Also present Fire Official Robert Schmitt and Fire Chief James Schmitt

Chairman Speciale called the meeting to order at 7:00 PM.

Statement of Open Public Meeting Act Compliance read by Chairman Speciale

Chairman Speciale led the flag salute.

R. Cain Jr. reported the painting should be completed by the end of this week.

D. Hainzl requested, on behalf of the Volunteers, if they chose to go with Direct TV would they be able to install the dish on the building. The Commissioners unanimously agreed that they can put it on the side of the building but not on the roof, as it is a membrane roof and if it gets punctured the warranty would be voided.

Liaison to Fire Prevention: No Report

R. Cain Jr. said all insurance is up to date. We have been notified by our insurance carrier that we should adopt a policy that when non fire department members are on the fire apparatus they must all be seated properly and using seatbelts. Also, any truck that has nonmembers on it would be out of service for fire calls and is not to respond to fire calls.

Budget & Finance: No Report

The annual preventative maintenance has been completed on all trucks. The ladder on 379 will be serviced 2-3 weeks prior to the ladder inspection. The pump service, ground ladder test and hose tests have been completed.

Motion by D. Hainzl to open meeting to the public seconded by R. Cain Jr. Deb Nielson, Montville Township Committee Woman addressed the Board to discuss the 150th anniversary celebration for Montville Township. A. Speciale suggested she contact

the Presidents and Chiefs of the Volunteer Fire Departments as they would be the ones to make these decisions. Chief James Schmitt said that the three Fire Departments would like to march as one for the celebration. Ms. Nielson said that they will have flags for the celebration, Pine Brook said they would be happy to display it. D. Hainzl asked about committees; Ms. Nielson said they are in need of volunteers for all committees.

Mike Neff, Pine Brook Volunteer Fire Department President, brought up the possibility of Direct TV. The Board explained to him about the membrane on the roof.

He made a motion that the Board purchase 10 lengths of 2 ½" hose @ \$ 184.31 per length and 3 lengths of colored hose of 1 ¾" hose @ \$135.56 per length, seconded by D. Hainzl. Motion passed by voice vote. Chief will remove the couplings from failed hose and throw the hose away.

A. Speciale said at this time Pine Brook Commissioners do not have anything for the Joint Commissioners meeting on July 27, 2016. Secretary will contact Montville and Towaco and if there is nothing to be discussed meeting will be canceled.

R. Cain Jr. presented a quote to purchase a new computer for the Fire Chiefs office. The cost of a Dell computer would be \$639.00. Motion by R. Cain Jr. to purchase the computer seconded by D. Hainzl. Motion passed by voice vote.
